Chair Bridge stated that if a person or public body does not make oral submissions at a public meeting or make written submissions to the County of Wellington before the By-law adopting the Official Plan is passed, the person or public body is not entitled to appeal the decision of the County of Wellington to the Ontario Municipal Board and the person or public body may not be added as a party to the hearing of the appeal before the Board unless, in the opinion of the Board, there are reasonable grounds to do so.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the Town of Minto before the Zoning By-law Amendment is passed, the person or public body is not entitled to appeal the decision of the Town of Minto to the Ontario Municipal Board and the person or public body may not be added as a party to the hearing of the appeal before the Board unless, in the opinion of the Board, there are reasonable grounds to do so.

C.A.O. Clerk White provided the legal description and municipal address of the lands and noted the applications is to re-designate part of the property from Recreational to Residential in the County Official Plan, and rezone the same lands from Open Space (OS) to Residential (R2) to allow construction of a single detached home. The amendment fulfills conditions of consent application B70/16. He advised notice was mailed to landowners within 120 meters of the lands, to applicable agencies and posted on site July 25<sup>th</sup>, 2017. Comments were received from Town of Minto staff, Linda Redmond, County Manager of Planning and Environment and Maitland Valley Conservation Authority with no concerns.

Chair Bridge called on the applicant or his agent to provide comments. David Will was in attendance and answered questions. Chair Bridge called on persons wishing to comment in favour or opposition of the proposed amendments and no one came forward.

The C.A.O. Clerk White described the property location and municipal address noting the application is to rezone the subject lands to prohibit future residential development on the agricultural (retained) portion of property and recognize a reduced minimum lot area for the residential (severed) portion. Rezoning is a condition of severance application B40/17 He advised notice was mailed to landowners within 120 meters of the lands, to applicable agencies and posted on site August 9<sup>th</sup>, 2017. Comments were received from Town of

Minto staff and Curtis Marshall, Senior Planner of the County of Wellington. Marshall noted the proposal conforms to the Official Plan and the County has no concerns.

Chair Bridge called on the applicant or agent, and then anyone wishing to comment in favour or opposed to the application. No persons came forward. Council had no questions.
