MYAC members recapped 2017 accomplishments and events and presented plans for 2018. Recommendations to Council include indoor-outdoor spaces in three urban areas for youth to socialize, equipping outdoor spaces with sitting areas, and basketball, volleyball and outdoor ping pong for youth. # b. County Councillor David Anderson, County Update

County Councillor Anderson reported on County Scholarships and Bursaries, OPP Report, Library Use, proposed Teviotdale Roundabout, Social Housing and Childcare. Three of ten bursary recipients were Minto residents. The new daycare under construction in Palmerston will have room for 15 toddlers 10 infants and 24 pre-schoolers, The County went ahead with a property tax exemption for social housing allowed by Provincial legislation. The impact on the Town budget is about 1%, but all funds will be re-invested in housing. The 11 unit housing project in Palmerston is a \$3 million investment.

Council indicated concern with the process by which the property tax exemption occurred. Councillor Anderson will bring this forward to the County. Deputy Mayor Faulkner thanked County Councillor Anderson for his report.
