#### 9. Delegations

Council moved back to Item 8 Public Meetings at 7:37 p.m.

8 a. ZBA-2016-06 Metzger 24 George Street amendment to Zoning By-law No. 01-86 Part Park Lots 4, 5 and 6, RP 61R-20210 Parts 9, 10,11

Chair Bridge called the meeting to order asking members of the public to sign the attendance record. He stated "if a person or public body does not make oral submissions at a public meeting or make written submissions to the Town of Minto before the By-law is passed, the person or public body is not entitled to appeal the decision of the Town of Minto to the Ontario Municipal Board and the person or public body may not be added as a party to the hearing of the appeal before the Board unless, in the opinion of the Board, there are reasonable grounds to do so."

C.A.O. Clerk White described the location of the property, and noted the proposed rezoning affects PART A and PART B properties differently. On the lands shown as A, the proposal is to rezone the lands from Open Space (OS) to Residential Exception Zone (R2-46) to allow the development of townhouses. On the lands shown as B, the proposal is to allow relief from the required rear yard setback and distance between buildings. The applicants propose to construct a 23 unit townhouse development. Further variances may be required as determined at the public meeting.

Notice was given to property owners within 120 meters of the subject property, applicable agencies and posted on the subject lands May 13, 2016. Comments received from the following agencies and members of the public were available on the agenda:

- Town of Minto staff Chief Building Official Terry Kuipers present to summarize.
- Wellington County Manager of Planning and Environment Mark Van Patter also present.
- Maitland Valley Conservation Authority (MVCA) Environmental Planner Brandi Walter noting the emergency access is not fully built, and to assess the application she requires a revised Cut/Fill Concept Plan with calculations showing impact on the floodplain, a revised grading plan showing development on PART A & B will be floodproofed with safe ingress/egress, and a topographic survey showing the entire emergency access has been constructed.
- Ross Wilkie letter of 26 in favour of the amendment due to the need for seniors housing and supporting the community working together on solutions.
- Neil Murray May 27 letter opposing the amendment to reduce the park and make changes as he has an agreement to rent a home and housing is needed right away.
- Peggy Newman letter dated May 29 opposing the amendment as she bought her home based on it backing on the park and pond, loss of green space, closer buildings, MVCA compliance and loss of condo ownership.
- Tracey Crispin's June 2 letter opposes the amendment as her home was bought because it backed on park, MVCA compliance, loss of condo ownership and drainage
- Ken Porter letter received June 2 in opposition to the amendment due to lack of accurate plans, construction starting before permits, reduced greenspace, procedure and maintenance standards.

The following comment received June 7 before the meeting and copied to Council:

 Rolf and Kerri Schuttel letter opposing the amendment as their home was purchased based on it backing on the park and pond, impacts of the loss of green space, MVCA compliance, work starting early, and density. Jeff Metzger alternate site plan drawings received June 7, 2016 (distributed to Council
at the meeting).

Copies of this correspondence were distributed during the meeting.

Chief Building Official Kuipers reviewed the Town staff report explaining the different zoning requirements to be changed and answered questions on the proposed rezoning. County Manager of Planning and Environment Mark Van Patter reviewed his report noting stormwater work is needed before an amendment is drafted. He also answered questions on the development.

Chair Bridge called on the applicants to provide comments. Jeremy and Jeff Metzger spoke about setback changes needed due to lot encroachments by abutting landowners. They explained plans brought to Council before buying the lands were concepts and many things have come to light during development. There is more than enough park space in Harriston and there is a need for Seniors Housing which the Town had encouraged them to fill. They have found no interest in condos, but seniors want rentals with maintenance provided.

Chair Bridge called on anyone who wishes to comment in favour of the proposed amendment. Neil Murray stated they sold their house to move into one of the units in October and asked about length of the process.

Chair Bridge called on those wishing to comment in opposition to the proposed Amendment. Ken Porter of 61 George St. N., brought forward concerns such as project ownership, development process, construction times, lack of details on accessibility, parking, snow storage, lighting, garbage and recyclables.

Philip Rowdan of 25 Lawrence Avenue had concerns with privacy due to closeness of the buildings and asked if a privacy fence would be erected.

Kerri Schuttel of 50 George St. N., noted she purchased in April because of the park land behind as shown on promotional material including the developer's website. She expressed concern about process without approvals and plans, and grading of the park and pond relative to her lot. The Chief Building Official explained the process applying to lot grading for homes on George Street, and that a final grading plan is needed for this project.

Tracey Crispin of 58 George St. N. and Peggy Newman of 54 George St N. spoke on concerns about changing the pond and park to townhouses and the impact on their homes. They expressed concern with a rental housing being provided instead of condos.

Council asked questions as did some present in the audience. There was discussion of process, ownership and development.

Chair Bridge called upon the applicant to respond to any of the matters raised. Jeff and Jeremy Metzger indicated the emergency access is completed and they met with MVCA to review the requirements for elevations. They believe they can meet the grading and drainage requirements and still provide a large open green space area bigger than some of their earlier concepts. The height of the proposed townhouses to go into the current green space is 14 feet, the same or lower that the homes on George Street.

The C.A.O. Clerk confirmed there is no by-law available for adoption and notice is provided to those request notice of further proceedings before Council. Mayor Bridge suggested due to time constraints a proposal come back at the June 21 meeting.

Chair Bridge stated "if you wish to be notified of the decision of the Council of the Town of Minto in respect to the proposed Zoning By-law Amendment application, you must make a written request to the Clerk of the Town of Minto at 5941 Highway 89, Harriston, NOG 1ZO or by email at Bwhite@town.minto.on.ca."

With no further comments, Chair Bridge adjourned the Public Meeting at 8:59 pm. There was a brief adjournment while attendees left the meeting.

b. ZBA-2016-07 Robinson/Metzger 401-423 Jane StreetPart Lot 22, Concession 1, Geographic Township of Minto

Chair Bridge called the meeting to order asking members of the public to sign the attendance record. He stated "if a person or public body does not make oral submissions at a public meeting or make written submissions to the Town of Minto before the By-law is passed, the person or public body is not entitled to appeal the decision of the Town of Minto to the Ontario Municipal Board and the person or public body may not be added as a party to the hearing of the appeal before the Board unless, in the opinion of the Board, there are reasonable grounds to do so."

C.A.O. Clerk White described the location of the property, and noted the proposed rezoning is to allow limited residential development on the lands. The amendment is to allow limited residential development on the lands. Four lots have been in existence for over 100 years and are within the Agricultural zone. Consideration will be given to what portions may be developed at this time, reducing setbacks to an urban standard, and possibly using "holding" to phase development to make more efficient use of the existing lots, and allow for pre-servicing during the reconstruction of Jane Street.

Notice was given to property owners within 120 meters of the subject property, applicable agencies and posted on the lands May 13. Comments received before the meeting and posted in the agenda were as follows:

- Town staff explaining the rezoning, requesting frontage fees to be paid, and noting the reserves and easement.
- Manager of Planning and Environment Mark Van Patter supporting the amendment to allow pre-servicing of residential lots although a permit from the Conservation Authority is needed due to the "floodway".
- Maitland Valley Conservation Authority (MVCA) Environmental Planner Brandi Walters noted the properties are located within the Regional Storm Floodplain and recommended the floodplain be assessed for a two zone concept.

A letter from Christine Roberts of 422 Jane St., Palmerston hand delivered before the meeting was read opposing the amendment due to residential impacting the rural setting.

Mark Van Patter stated that the lands can be developed for rural residential if not for the Town easement and reserve in front of the lots. If the zoning is passed, MVCA approval is required before a building permit can be given. Council asked questions of Mr. Van Patter and the Chief Building Official

Chair Bridge called on the applicant or his agent to provide comments regarding the proposed Amendment to the Comprehensive Zoning By-law No. 01-86. Jeff Metzger (developer) and Kathy Robinson (owner) spoke to the amendment and noted that they received the information from MVCA regarding the flood zone on June 3, 2016. Having spoken to the MVCA they believe a fill and construction permit is all that is required/

Chair Bridge called on anyone who wished to comment in favour of the proposed Amendment, no one came forward. Chair Bridge called on anyone wanting to comment in opposition.

Dan Wurmli, owner of the neighbouring farm at 221 Mary Street stated that in the spring there is flooding both on the lots and his own property. He is also concerned with future building plans increasing flooding and new residents raising complaints regarding odour and noise from the farm animals.

There was general discussion about drainage and the impact of the urban boundary on MDS setbacks. The farm is already restricted by the urban boundary. The Roads & Drainage Foreman explained the layout of the municipal drain in the area.
