# 5. Public Meeting

## a. ZBA 2024-01, Lavolit Ltd - 5113 Wellington Road 87

Mayor Turton acted as the Chair of the Public Meeting and called the meeting to order at 3:02 p.m. asking any member of the public present is recorded on the attendance record. Chair Turton stated if a person or public body does not make oral submissions at a public meeting or make written submissions to the Town of Minto before the by-law is passed, the person or public body is not entitled to appeal the decision of the Town of Minto to the Ontario Land Tribunal and the person or public body may not be added as a party to the hearing of the appeal before the Tribunal unless, in the opinion of the Board, there are reasonable grounds to do so.

Clerk McRobb stated the property subject to the proposed amendment is located at Concession 8 Part Lot 42 Concession 9 Part; Gore Lot 42 and municipally known as 5113 Wellington Rd 87 in the Town of Minto. The subject property is approximately 41 ha (101.31 ac) in size. The purpose and effect of the proposed amendment is to rezone the subject lands to prohibit future residential development on the retained agricultural portion of property. This rezoning is a condition of severance application B81/23, which has been granted provisional consent by the Wellington County Land Division Committee. The consent will sever a 0.63 ha (1.6 ac) parcel with an existing dwelling. A 40 ha (98.84 ac) agricultural parcel would be retained. Additional relief may be considered at this meeting. The notices were mailed to the property owners within 400 feet or 120 meters of the subject property as well as the applicable agencies and posted on the subject property on February 20th, 2024.
