The purpose and effect of this Minor Variance application is to provide relief from Clause 13.2.3.1) of the Town of Minto's Comprehensive Zoning By-law 01-86, as amended, to provide relief from the minimum lot area requirement within the R3 Zone for a proposed 20 unit apartment building. Clause 13.2.3.1) which requires a minimum lot area of 3,223.8m² (34,687.95 ft²), whereas the existing site is approximately 2,806m² (30,236.46 ft²) in size.

WE, the undersigned, in making the decision upon this application, have considered whether or not the variance requested was minor and desirable for the appropriate development or use of the land, building or structure, and that the general intent and purpose of the Zoning By-law and the Official Plan will be maintained or, in the case of a change in the use of property which is lawfully non-conforming under the By-law, as to whether or not this application has met the requirements of subsection 45(2) of *The Planning Act*, concur in the following decision and reasons for decision made on the 04th day of June 2024.

DECISION: **Approves** the application by Surinder Chaudhry for property legally described as MINTO CON 1 PT LOTS 21 22;FULLER AND WATSONS SURVEY;LOTS 72 TO 74 PT LOT 71 RP;61R20712 PARTS 1 2 3 AND 6, municipally known as 255 Norman Street, Palmerston, in the Town of Minto, to provide relief from Clause 13.2.3.1) which requires a minimum lot area of 3,223.8m² (34,687.95 ft²).
