Barkley Knapp President and Katherine Noble presented a video and key take aways from the study for Council.

d. Jim Dopfer and Debra Dennison, Further Delegation regarding Petition

Jim Dopfer noted that he is one of the organizers of the petition. Dopfer stated he was here to explain and clarify the meaning of the petition and neutrality:

- The request for a By-law for Neutrality in the Town of Minto in Public spaces has nothing to do with the draft policy being presented on the agenda.
- The petition has nothing to do with hate.
- The Supreme Court of Canada in 2015 ruled against prayer in Council meetings.
- Government of any level should not be involved in personal choice matters of individuals.

Debra Dennison noted that the petition states to make a By-law ensuring crosswalks and flags/banners on public property remain neutral, adhering to the following: crosswalks will only be painted in the standard white striped pattern (continental or ladder) between two parallel lines. Only the national flag of Canada, provincial flag of Ontario, or Town of Minto flags are raised on flagpoles on public property or facilities. There will be no decorations on Town crosswalks or displaying flags/banners supporting political, social or religious movements or commercial entities, save and except the Royal Canadian Legion banners which are considered grandfathered in.

Council asked questions of the delegates.

Dan Sinclair asked do you not think that these concerned taxpayers of Minto deserve to vote versus solely the members of Council on this matter and any other controversial matter in the Town of Minto?

Meg Young asked for information on the cost of the DEI and Pride committees including Pride in the Park.

Stefon von Muhlenen asked how democracy in this town works?

Franny von Muhlenen asked do we not learn from history?

Irene Dooley asked is it considered a fair practice for a Town employee to inject their own opinions to others of this same petitions even before it had been presented to Council or been discussed with the organizers?

Irma DeVries asked if Council was concerned about the health of the people that participate in this (homosexuality)?

Joanne Belair of Palmerston asked how the group (Pride) we are speaking about requested the banners? Was there a lack of inclusiveness that led to this request? Is the problem with the word neutrality?

Tony Andrade asked why he just read about this in the paper, and shouldn't everyone get to know about this?

Debra Dennison noted the correspondence to raise a flag (Pride) on May 31<sup>st</sup> on the Council agenda and asked will it still be raised? How do we say we are not in favour of that flag?

County Councillor Anderson challenged the residents of Minto to get involved.

Dan Sinclair asked Deputy Mayor Anderson why do you feel personally that all Canadians cannot fly under the Canada flag?
