### Community Sport and Recreation Infrastructure Fund

Director of Community Services Lubbers spoke about the possibility of applying for the Community Sport and Recreation Infrastructure Fund. Funding for municipalities in either the Repair and Rehabilitation or New Builds stream is 50% (70% under unique and exceptional

circumstances) including between \$150,000 - \$1 million for repair and rehabilitation as well as up to \$10 million for new builds.

The challenge when determining a project to apply for is that if successful, the municipality must plan to come up with their share of funding. Town staff have met with the Rotary Club of Clifford over the past few months to discuss the viability of building a splash pad in Clifford. At their meeting tomorrow night, they will consider making a significant financial contribution towards this project. Anticipated project cost of a splash pad is \$250.000.
