

Robert told me that he did purchase a fence for the property to have the property fenced in. Robert also told me that the dog is always on leash now when it is outside. I explained to Robert that the township does have to take action on the incident and that putting up a fence and making sure the dog is always leashed outside are good steps to take. On Tuesday July 30th, 2024, your dog Bowie, a Labradoodle type dog, attacked and bit a person, that was walking on Regency Drive, causing damage to the person's back leg that required the person to seek medical treatment resulting in 10 stitches and ongoing treatment. For this reason, the Dog Control Officer has designated your dog as a dangerous dog.

- 5. "Dangerous Dog"
- a) Means a dog that, in the absence of any mitigating factor, has attacked, bitten or caused injury to a person or has demonstrated a propensity, tendency or disposition to do so;

Please accept this notice that the Dog Control Officer designates your dog Bowie as a Dangerous Dog pursuant to the Town of Minto Dog Licensing By-law 2019-39.

Where the owner of a dog receives a notice from the Dog Control Officer designating such dog as a Potentially Dangerous or Dangerous Dog and so requests in writing to the Clerk of the Town within three working days of receipt of such notice, Council shall hold a hearing pursuant to the provisions of the Statutory Powers Procedures Act within 15 working days of the Clerk's receipt of the request for a hearing and may:

- a) Affirm, amend or rescind the Dog Control Officer's designation of the dog as a Potentially Dangerous Dog or as a Dangerous Dog, as the case may be:
- b) Substitute its own designation of the dog as a Potentially Dangerous or Dangerous Dog, as the case may be; and/or,
- c) Substitute its own requirement/conditions of the owner of a Potentially Dangerous Dog pursuant to Subsection L. 4.

As the owner of a dog that has been deemed as a Dangerous Dog, you will be required to:

- 4. Where the Dog Control Officer designates a dog as a Potentially Dangerous Dog or Dangerous Dog, the Dog Control Officer shall serve notice upon the owner of such dog requiring the owner, upon receipt of such notice to comply with the following requirements, as determined by the Dog Control Officer:
- a) Shall keep such dog confined within the owner's dwelling, or in an enclosed pen of sufficient dimension and construction to provide

- humane shelter for the dog while preventing the entry therein of unsupervised children;
- b) Shall securely attach a muzzle to such dog at all times when it is not confined in accordance with Clause L.4. a);
- c) Shall obtain and maintain in force a policy of public liability insurance issued by an insurer licensed by the Province of Ontario providing third party liability coverage in an amount of not less than \$1,000,000.00 for any damage or injury caused by such Dangerous Dog and provide to the Dog Control Officer a certificate of such policy and each subsequent renewal thereafter. Such policy shall contain a provision requiring the insurer to immediately notify the Dog Control Officer should the policy expire, be cancelled or be terminated for any reason; and,
- d) Provide the Dog Control Officer with a certificate indicating that a microchip has been implanted identifying such dog as a Potentially Dangerous Dog or Dangerous Dog as designated.
- e) Shall display a sign at each entrance to the property and to the building, in which the dog is kept, warning in writing, that there is a Dangerous Dog on the property. This sign shall be visible and legible from the nearest road or thoroughfare.
- 9. An owner of a dog which has been designated a Potentially Dangerous or Dangerous Dog pursuant to this By-law, shall advise the Dog Control Officer immediately if he/she transfers ownership of such dog to another person or changes the address at which such dog is kept and furnish the Dog Control Officer with particulars of same.

th D ir	We understand the process has a provision for a hearing to review the restrictions imposed under the By-law, but were not aware that Minto had granted an exemption to the automatic Dangerous log designation and muzzling requirements outlined in the By-law. Was this done as part of the impound/quarantine completion? Is the decision to exempt these requirements based on compliance to having the protection of a fence in place (which we understand it is); or is it done at the discretion of Council?
a b h	We recognise the By-Law provides protection to both the public and dog owners. We want to be ware of what restrictions are in place for this dog under the By-Law, and which restrictions have een granted an exemption, based on Minto's assessment. Knowing what was imposed from the earing will allow us to establish the correct expectations of how this dog is being managed moving prward.

The town of Minto is currently keeping track of the fence that will be going up to enclose the property. The town of Minto does not make surrounding neighbour's aware of the situation since we have to uphold a level of privacy. Any dog that is off leash can be reported to the town since all dogs have to be leashed on town property. The dangerous dog signs come when the dog is designated by the town. We did confirm with the owner that this is the first incident and the town does not have records of any other incident.

You have indicated in your response that the dog must be always leashed when going outside of the fenced yard or anywhere it is not contained. Please confirm this also includes the muzzling requirements spelled out in the by-law for dogs that have bitten.

Most neighbors have expressed they have long harbored fears related to this dog since learning of the attack. You indicate that area neighbors should notify you if they see the dog off leash. How does the Town of Minto make the surrounding neighbors aware of the permanent restrictions imposed on the dog, the reporting process, and the protections they are entitled to? In addition, please confirm there will be a visible and legible sign at each entrance to their property, warning that there is a Dangerous Dog on site.

You have confirmed that this unprovoked attack on our mother is the first incident with this dog. Please confirm the immediate actions if there is a second incident with this dog?

Adding family members to this email request.

Could you please update myself and my family (cc'd here) with regards to what is happening with this dog (and their owners) that bit my mother in-law, Stella Wallace, unprovoked back on July 30th 2024.

What is the policy of dog bites in Minto?

To date, Stella has had to endure the following;

- ER visit that resulted in 10 stitches
- Within a week the wound became Infected and she was placed on antibiotics
- Lack of wound healing and needing to have ongoing treatment with a Wound Care
 Specialist
- Wound not healing and needed debridement
- Continued lack of wound healing resulted in stopping her current cancer treatments
- Tomorrow (August 27th) marks 1 month since this bite occurred

- She is unable to walk around her own subdivision out of fear of this dog
- She is struggling when seeing or even hearing other dogs and is emotionally shaken by this incident and its ongoing after effects

We are all left feeling rather concerned over what appears to be significant complacency around this entire issue, including the lack of information from the Township on what they are doing or what they can do, let alone the 2+ weeks it took to even get the Townships attention to this concern.

I have received information from Rick Hobbelink that you received a dangerous dog designation for your dog Bowie as of yesterday and you are requesting information on challenging the designation.

Section L 6 of By-law 2019-39 (to Regulate and License the Keeping of Dogs and Dog Kennels in the Town of Minto) states the following:

Where the owner of a dog receives a notice from the Dog Control Officer designating such dog as a Potentially Dangerous or Dangerous Dog and so requests in writing to the Clerk of the Town within three working days of receipt of such notice, Council shall hold a hearing pursuant to the provisions of the Statutory Powers Procedures Act within 15 working days of the Clerk's receipt of the request for a hearing and may:

a. Affirm, amend or rescind the Dog Control Officer's designation of the dog as a Potentially Dangerous Dog or as a Dangerous Dog, as the case may be;

- b. Substitute its own designation of the dog as a Potentially Dangerous or Dangerous Dog, as the case may be; and/or,
- c. Substitute its own requirements/conditions of the owner of a Potentially Dangerous Dog pursuant to Subsection L. 4.

You would be required to send me notice (by email or hand delivered letter) by no later than 5 pm on Thursday September 12th, 2024 that you wish to have a hearing regarding the Dangerous Dog designation for Bowie. If I do receive this correspondence from you a hearing would be scheduled for October 1st, 2024. I would send you further information on the hearing after I receive a request from you. I hope this answers your questions.
