## **RECOMMENDATIONS:**

THAT the Council of the Town of Minto hereby receives report PW 2025-005 Tender Results – Asphalt, Gravel, Dust Suppression, prepared by the Roads and Drainage Manager, for information purposes;

AND FURTHER THAT the Council of the Town of Minto awards Tender 2025-03; Supply and Apply Dust Suppressant to Da-Lee Dust Control for a unit price of \$525.65 per flake equivalent ton excluding HST;

AND FURTHER THAT the Council of the Town of Minto awards Tender 2025-04; Supply, Load, Haul and Spread Granular 'A' (Maintenance Gravel) to Walker Aggregates Inc. for a unit price of \$14.75 per ton excluding HST;

AND FURTHER THAT the Council of the Town of Minto awards Tender 2025-05, Asphalt Resurfacing to E.C. King Contracting for a total of tender amount of \$699,931.35 excluding HST.

The Dust Suppressant Tender 2025-03, Maintenance Gravel Tender 2025-04, and Asphalt Resurfacing Tender 2025-05 all closed on February 11, 2025.
