### Schedule 'B' Minutes of the Committee of Adjustment MV 2025-002 – Andrew Bauman 8803 1st Line

Chair Turton called the Public Hearing to order at 3:11 p.m. and stated any decision reached by this Committee today cannot be used to set a precedent. Each application considered by the Committee is dealt with on its own merits and no two applications are exactly the same. Chair Turton stated the Public Hearing is to consider Minor Variance Application: MV-2025-02 Andrew Bauman.

Secretary-Treasurer McRobb stated the property subject to the proposed Minor Variance application is legally described as CON D PT LOT 111 RP 60R2487; PART 1 and is municipally known as 8803 1st Line in the Town of Minto. The subject property is approximately 1.61 ha (4 ac).

The purpose and effect of this Minor Variance application is to seek relief from the maximum ground floor area requirements for accessory buildings and structures in order to build a four-season greenhouse. Clause 8.5.2.8 of the Town of Minto's Comprehensive Zoning Bylaw 01-86, as amended, specifies a maximum ground floor area of 3,350 ft² (311.72 m²); however, a ground floor area of 6,256 ft² (581.76 m²) is proposed. Additional relief may be considered at this meeting.

The notices were mailed to the property owners within 200 feet or 60 meters of the subject property as well as the applicable agencies on March 18th, 2025 and posted on the subject property on March 18th, 2025.

Reports/comments were received from Sama Haghighi, Planning Coordinator, Town of Minto and Asavari Jadhav-Admane, Planner; Wellington County.

Secretary-Treasurer McRobb advised the Committee that no speakers registered to participate in the Public Hearing.

Chair Turton to call on the Town of Minto's Planning Coordinator to provide comments. Sama Haghighi reviewed the reports from the Town of Minto.

Chair Turton to call on the owner/applicant to provide comments. Andrew Bauman was in attendance and had no comments.

Chair Turton to request any persons wishing to speak to the application to come forward. Noone came forward.

Chair Turton asked for any questions by the Committee.
