A Public Meeting to consider an amendment to the Town of Minto Zoning By-law No. 01-86 for property located on Part Lot 33, S/S Queen Street., municipally known as 21 William Street E.

- 1. Deputy Mayor Bridge to act as the Chair of the Public Meeting
- 2. Chair Bridge to call the meeting to order and request any member of the public present to please sign the attendance record. Chair Bridge to state the following:

If a person or public body does not make oral submissions at a public meeting or make written submissions to the Town of Minto before the By-law is passed, the person or public body is not entitled to appeal the decision of the Town of Minto to the Ontario Municipal Board and the person or public body may not be added as a party to the hearing of the appeal before the Board unless, in the opinion of the Board, there are reasonable grounds to do so.

3. Deputy C.A.O. Clerk Duff to state the municipal address and legal description of the property, the purpose and effect of the application and date notices we sent.

The property subject to the proposed amendment is located on Part Lot 33, S/S Queen Street., municipally known as 21 William Street E.

The Purpose and Effect of the proposed amendment is to rezone the subject lands to permit a reduced lot area and frontage for the proposed severed lot, and a reduced lot area for the retained lot. The application for rezoning is a condition of consent that will severe the vacant parcel (426.87 m² or 4594.8 ft²) from the retained parcel (549.36 m² or 5913.2 ft²) occupied by an existing residential dwelling to allow a future residential building lot. This property is zoned R1B Low Density Residential.

The Notices were mailed to the property owners within 400 feet or 120 meters of the subject property as well as the applicable agencies and posted on the subject property on August 25th, 2017 The following comments were received:
