



In a <u>column in the Law Times</u> this week, Ombudsman Paul Dubé says he is among those "cautiously welcoming" the proposed legislative changes to police oversight in Ontario, several of which reflect key recommendations he made to the province's independent review last year. On November 2, the provincial government introduced the <u>Safer Ontario</u> <u>Act</u>, which would extend the Ombudsman's mandate to include all three of the province's revamped police oversight bodies, and require them to collect demographic information on interactions between civilians and police.


"We should all take note of these proposed reforms and monitor their effectiveness in promoting police accountability," Ombudsman Dubé writes in the piece, noting that the bill also proposes to bolster the Special Investigations Unit (which probes policeinvolved deaths and serious injuries of civilians) with standalone legislation that includes consequences for police services that fail to co-operate with it. These reforms were also recommended in Mr. Dubé's 2016 <u>submission</u> and in our Office's <u>2008</u> and <u>2011</u> reports on investigations of the SIU.



At the same time, Mr. Dubé writes, a key reform the bill does not address is de-escalation training for police officers to help them deal with people who have mental health challenges or are in crisis, as he recommended in his 2016 report, <u>A Matter of Life and</u> <u>Death</u>. Although all of his recommendations were accepted - including a new use-of-force model and mandatory training to ensure police use de-escalation techniques whenever possible before using weapons, "there has been little visible movement on this issue," he notes in the column. "Change must also happen on the front lines, where officers meet

people in crisis face to face," he writes, adding that he is hopeful this potentially life-saving change will soon follow the new bill.

A man contacted our Office after being told the Family Responsibility Office would be garnishing his wages, which would force him and his family to be evicted from their home. BROADER PUBLIC SECTOR CASES

The Ombudsman's mandate was expanded to include school boards on September 1, 2015, and to municipalities and universities on January 1, 2016. To date, we've received 1,923 cases about school boards, 5,734 cases about municipalities and 413 cases about universities.

Like most of the 21,000-plus cases we receive each year, all but a few of these have been resolved without need for formal investigation.
