Budget to Actual Issues

This area is over budget due to expenses related to the June 23 flood The 1:100 year storm caused several million dollars in private property damage to about 150 locations, mainly in Harriston. The Town is awaiting response from the Province of Ontario on funding eligibility since Town expenses exceeded the minimum threshold (\$145,000). If the application is approved some of the budget overage due to the flood will be refunded. The Treasury Department has participated in a webinar on this program. The process to obtain reimbursement is extensive even if the Town is eligible.



Council received an After Action Report which characterized the nature of the response by the Town and other emergency services. The Conservation Authority, Town and other responders originally proposed to host a public meeting this fall, but this has been delayed because some landowners are still cleaning up and the Town and Conservation Authority should have more information on flood plain mapping and hydrology this spring that should be provided to the public.

The Town has applied for assistance under the National Disaster Mitigation Program for 50% funding of detailed flood plain mapping for the Maitland River Watershed. As per Council resolution the attached application details the general terms of reference for the project. The application is accepted by the Province and has moved to the second stage of the NDMP program. The 2018 budget includes \$132,000 for this project with 50% funding from the NDMP program.

Issues for 2018 and Beyond

Conservation Authorities levies have been stable in Minto because assessment growth lagged behind other member municipalities. Trees for Minto were active in 2017 and will be supported by added TLC staff support. The idea of merging Trees for Minto with the Trails Committee is worth some discussion to try and reduce administration.

The Town signed a three year agreement with R & R Pet Paradise for animal control services in later November. This significantly upgrades care for dogs captured at large in Minto with a proper climate controlled shelter that meets Provincial standards. The budget has been increased to account for the new contract which does not have an increase through 2020. Dog tag costs were increased from \$12 to \$20 in 2017 in preparation for future cost increases for animal control. The tags cover the cost of the contract plus some staff time for this service.
